INDUSTRY INCENTIVES

Governor's Agriculture + Forestry Industries Development Fund	A grant available to businesses that add value to Virginia-grown agriculture and forestry products
Commonwealth's Development Opportunity Fund	A discretionary, "deal closing" fund to secure a company location or expansion in Virginia and create an incentive to create new jobs
Port Volume Increase Tax Credit	Tax credit for manufacturers or distributors that increase port usage
Virginia Economic Development Incentive Grant	Assists companies to invest and to provide new job opportunities by locating significant headquarters, administrative, or service sector operations in Virginia
Virginia Jobs Investment Program	Supports the creation of new jobs and investment and helps businesses train new and existing workers
The Port of Va. Economic + Infrastructure Development Grant	Incentivizes companies to locate new maritime- related employment centers or expand existing centers to encourage growth of The Port of Virginia
Major Business Facility Job Tax Credit	Qualified companies locating or expanding in Virginia receive a \$1,000 corporate income tax credit for each new full-time job creation over a threshold number
